2. The Lottery is open to all physical customers of LIDL MALTA LTD. outlets in both Malta and Gozo, residing in either Malta or Gozo.
3. No commercial entities, buying groups, or organisations will be allowed to participate in the Lottery.

6. Registration and participation in LIDL MALTA LTD.'s 10th Anniversary Lottery will be open from 06:59 on Monday 30th April, 2018 to 23:59 on Tuesday 29th May, 2018.
7. Lidl customers must spend a minimum of €35 [thirty five Euros] to enter with a single try to participate with the chance to win both the Prizes. Should the customer's total value of purchase on single cashier chit be greater than €35 [thirty five Euros] – then the customer will automatically be awarded multiple chances to win, the number of which will be directly proportionate to the value of the purchase expressed in units of the minimum value, e.g. €35 [thirty five Euros] equals one (1) try, €70 [seventy Euros] equals two (2) tries, €105 [one hundred and five Euros] equals three (3) tries, €140 [one hundred and forty Euros] equals four (4) tries, etc.).

8. Daily Prize: One winner per day will be randomly selected for 30 [thirty] days and will win a voucher that will entitle the holder to exchange this for goods purchased at any LIDL MALTA LTD. outlet of their choice in both Malta and Gozo; to the total value of €100 [one hundred Euros].
9. Final Prize: All validated participants in the LIDL MALTA LTD. 10th Anniversary Lottery will be entitled to enter with the chance to win the grand Final Prize of 52 [fifty-two] vouchers of a value of €50 [fifty Euros] each per year for ten [10] years. The vouchers may be used only in the month and year of validity shown on them at a Lidl sales point in Malta and Gozo. The vouchers will be nominative: the name of the winner will be shown on the voucher and up to one other name of a person related to the winner (communicated to JPA and LIDL MALTA LTD by the winner). The vouchers can only be used by the names shown on them, after showing a valid identity document.

Registration Process for the LIDL MALTA LTD. 10th Anniversary Lottery

10. To be eligible to participate, each customer must correctly fill in their full contact details requested in the registration form and the information as reproduced on the official cashier chit recording the purchase:
 - a. Identification code of the sales point at the bottom of the chit, on the left side (4 digits, e.g. 7514);
 - b. The transaction code, shown centrally at the bottom of the ticket, given by the transaction number and the cash register number (e.g. 000048/01, for a total of 8 digits without "/" e.g. 00004801);
 - c. Date shown at the bottom of the chit, on the right side. The day and month must be entered as the year will already be pre-set in the registration form;
 - d. The value of purchase; and
 - e. The required personal data; including name, surname, email and telephone number.

Participation in LIDL MALTA LTD. 10th Anniversary Lottery

11. On successful completion of the registration process, the customer will be invited to proceed with actively taking their chance/s to win the instant daily prize – the number of chances will be determined by the value of the purchase recorded within the cashier chit.
12. At the end of this phase, the system will show a video message that will communicate the non-winner or instant winner of the instant daily prize. In the case of the customer has obtained additional participations (multiple receipt), the customer will be invited to try his luck another time, consequently displaying a further message with the result. The customer may decide to use the additional possibilities even at a different time on the same game day or on another day of play by filling out the participation form again.
13. Should the customers not be successful in winning the daily instant win – their registration will automatically entitle them to participate in the grand final draw. All registrations will be validated to be truthful in both their detail [date of purchase, place of purchase and personal] in conformity with the rules of this Lottery.
14. Customers are invited to register and participate with every valid purchase they fulfil during the period, even if they have already won one [1] or any number of daily prizes.
15. Each customer is entitled to multiple registrations and participations. Each purchase made by the customer at any LIDL Malta LTD outlet in Malta or Gozo of €35 [thirty five Euros] or more, will entitle them to a number of chances directly proportionate to the value of the individual cashier chit [€35 equals one chance, €75 two chances, etc.] in the Grand Final Draw of the 10th Anniversary Lottery.
16. In case of winnings or not winnings, the customer will also receive notice via e-mail at the address indicated on the registration form.
17. Should the customer win the daily instant prize – the site will communicate this instantly inviting the customer to validate their win by presenting themselves in person within five (5) working days from the win at the offices of our representatives JPA, Suites 5-7, Matilda Court, Giuseppe Cali Street, Ta' Xbiex, XBX1423 – from Monday to Friday, from 9.00am to 1.00pm and 2.00pm to 5.00pm [except public holidays].
18. Following a simple question pertaining to the brand – the winner will be required to present the following :
 - a. A photocopy of a valid identity card;
 - b. The original cashier chit clearly showing the minimum value of €35 [thirty five Euros] and issued in any LIDL MALTA LTD. outlet in Malta and Gozo, between 06:59 on Monday 30th April, 2018 to 23:59 on Tuesday 29th May, 2018. The cashier chit must be intact and free of abrasions or corrections and allow identification of the point of sale where the purchase was made and the total value of the receipt (minimum amount of expenditure €35) and the details reported in the registration phase;
 - c. The telephone number to be contacted if necessary;

- d. The address to which the prize will be sent.
19. On validation of the details of the cashier chit – the winner of the daily instant win will receive by post a voucher entitling the winner to exchange for a purchase of €100 at any LIDL MALTA LTD. outlet in both Malta and Gozo.
20. Should the winner fail in the validation stage – the prospective winner will lose all claims to their winnings – the prize will then be automatically pooled into a secondary tier in the Grand Final Draw.

Winnings

23. Daily Instant Win: The winner of the Daily Instant Win will be selected instantly at random – assigning one singular winner per day between the period from 06:59 on Monday 30th April, to 23:59 to Tuesday 29th May, 2018. Each selected drawn contestant will be invited to validate their purchase and answer a question pertaining to the LIDL brand.
24. Grand Final Draw: Following the closure of the registration period, a Grand Final Draw will be organised in 20th June 2018 in which all the confirmed and validated registrations will enter in a chance to win the Grand Final prize through a notarian single draw extraction. Once again – the extracted name will be invited to validate their purchase and answer a question pertaining to the LIDL brand.
25. Secondary Tier Draw: Should any Daily Instant Wins or the Grand Final Prize Winner fail to be validated – the respective prize/s will be assigned on the day of the Grand Final Draw through the drawing of an additional ten [10] reserve registrations. Validation of the second tier draws will follow similar procedures as that of the first tier.

The Winner of the Grand Final Draw will receive five hundred and twenty [520] individual vouchers – issued to the name on the registration and one [1] additional person [details to be communicated after the announcing of the winning].  - a. Its serial number (e.g. 1/520); and
